# NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.1817 per \$100 valuation has been proposed by the governing body of FORT CLARK MUD.

PROPOSED TAX RATE	\$0.1817 per \$100
NO-NEW-REVENUE TAX RATE	\$0.3417 per \$100
VOTER-APPROVAL TAX RATE	\$0.1817 per \$100

The no-new-revenue tax rate is the tax rate for the 2021 tax year that will raise the same amount of property tax revenue for FORT CLARK MUD from the same properties in both the 2020 tax year and the 2021 tax year.

The voter-approval rate is the highest tax rate that FORT CLARK MUD may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that FORT CLARK MUD is not proposing to increase property taxes for the 2021 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 15, 2021 at 9:00 AM at FtClark MUD Board Room.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, FORT CLARK MUD is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting Ft Clark MUD of FORT CLARK MUD at their offices or by attending the public meeting mentioned above.

YOUR TAXES OWED UNDER ANY OF THE TAX RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by FORT CLARK MUD last year to the taxes proposed to be imposed on the average residence homestead by FORT CLARK MUD this year.

	2020	2021	Change
<b>Total tax rate (per \$100 of value)</b>	\$0.3443	\$0.1817	47.22% decrease
<b>Average homestead taxable value</b>	\$86,734	\$92,668	6.84% increase
<b>Tax on average homestead</b>	\$299	\$168	43.81% decrease
<b>Total tax levy on all properties</b>	\$231,792	\$123,386	46.76% decrease
